



PERSONAL DATA TREATMENT INFORMATION IN ACCORDANCE WITH ART. 13 OF GDPR 2016/679

The personal data provided by you or collected by CSI Piemonte is processed according to the provisions of the European Regulation 2016/679 (hereinafter GDPR) concerning the protection of individuals with regard to the processing of personal data, as well as the free circulation of such data, and abrogates Directive 95/46/EC.

In accordance with art. 13 of the GDPR, we therefore provide you with the following information:

DATA CONTROLLER AND DATA PROTECTION OFFICER

The holder of the treatment of personal details is CSI Piemonte, with registered office in Turin, Corso Unione Sovietica 216 in the person of its Legal Representative (protocollo@cert.csi.it, phone 0113168111). AIMS OF THE TREATMENT

Your personal data is collected and processed in accordance with the principles of correctness, lawfulness, minimization of data and protection of confidentiality, exclusively for the following purposes:

- Collection and management of interest expressions towards potential collaborations (market area). This is aimed at the beginning of a comparison, with the purpose of identifying potential product offers and services to propose on the market jointly
- Collaboration formalization through the writing of negotiation forms which are most appropriate to the type of relationship identified in the comparison
- Participation in tenders of common interest through a temporary corporate group with CSI Piemonte
- Management of any disputes that cannot be solved in a friendly manner.

LEGAL BASIS OF THE TREATMENT

Providing your data is not mandatory but is necessary for the aforementioned purposes. The data processing therefore finds its legal basis in the execution of the necessary pre-



contractual measures or of the contract stipulated between the parties (art. 6, c. 1, lett. B of the GDPR).

TREATMENT PROCEDURES

Your data is processed in paper and electronic format. Data is treated exclusively by subjects who are authorized and instructed by the Data Controller. They are obliged to maintain confidentiality by bodies/companies expressly appointed as Data Processors. Your data may be processed directly, indirectly and/or incidentally also by entities connected to CSI Piemonte due to the services provided. In any case, your data is processed by adopting all the appropriate technical and organizational measures to protect the rights, freedom and legitimate interests that are recognized to you by law as an Interested Party.

DATA STORAGE

Your data is stored by the Consortium in compliance with the GDPR both in terms of processing and security for the entire duration of the collaboration. It is stored also in case of disputes and, subsequently, for archival purposes, for the period of time indicated in the company policies or in the mandatory (minimum) retention period adopted by CSI Piemonte.

COMMUNICATION AND TRANSFER OF DATA

Your personal data will in no way be the object of communication and distribution outside the cases provided for by law, nor will they be transferred to a non-European third country, nor to automated decision-making processes including profiling.

RIGHTS OF THE INTERESTED PARTIES

As an interested party you may use the rights provided for by the articles from 15 to 22 of the GDPR- in the indicated cases (including those of obtaining confirmation of the existence of your personal data and its availability in an intelligible form; of knowing the logic and purpose on which the treatment is based; of obtaining the cancellation or the transformation into anonymous form or the limitation or blocking of the data processed in violation of the law, as well as the updating, adjustment or, in case of interest, data integration; opposing to the treatment for legitimate reasons) by contacting the Data Controller or Data Protection Officer using the contact details above. You may also use the right to file a complaint to the supervisory authority or to take legal action through the competent judicial authorities if the processing of your personal data occurs in violation of the provisions of the GDPR, in accordance with articles 77 and 79 of the GDPR.
